Capital Raising: Placement Completion and Share Purchase Plan key dates

Qube Holdings Limited (**Company**) is pleased with the strong institutional demand for the fundraising undertaken yesterday and has successfully completed a placement of 94,339,623 fully paid ordinary shares (**Shares**) to institutional, sophisticated and professional investors to raise \$200 million (**Placement**). The Placement was conducted via a bookbuild managed by UBS AG, Australia Branch.

The issue price of \$2.12 represents a 4.9% discount to the closing price of Shares on 26 March 2014, the last trading day prior to the commencement of the Placement bookbuild.

The Share Purchase Plan (**SPP**) announced yesterday will provide eligible existing shareholders with the opportunity to subscribe for new Shares at the same price as the Placement issue price, and is open to shareholders registered at 7.00pm (Sydney time) on Wednesday, 26 March 2014 with a registered address in Australia or New Zealand (**Eligible Shareholders**). The SPP will be capped at a maximum total size of \$30 million.

The funds raised under the Placement and the SPP will be used to fund proposed capital expenditure associated with the Quattro Grain Joint Venture and related rolling stock, reduce debt and provide capacity to fund other capital expansion initiatives presently under consideration. Further details are set out in yesterday's announcement.
